REASONS FOR TELECOMMUTING

The Coronavirus Pandemic forced the City's finance department to change the way staff worked.

Due to the threat to public safety brought on by the outbreak of the Coronavirus, the City of Pacific decided to implement telecommuting to allow for social distancing at City Hall.

Telecommuting was not something that was put into common use by the City of Pacific staff on a regular basis until this recent viral outbreak. The newly hired Systems Analyst (in March 2020) has been quite busy procuring the necessary mobile computer equipment as well as setting the employees up on how to access the City's network remotely. In April and May the City had four department heads and up to five support staff using the telecommute option, either part or full time each week. The Zoom platform was also implemented to hold staff and Council meetings virtually.

While the driving force was one of public safety, studies show that the use of remote offices (working from home) saves \$11,000 in overhead costs per employee per year. Productivity has also proven to increase as 53% of telecommuters work more than 40 hours per week. I have also heard from telecommuting staff that they are more productive as they have less distractions and no time spent driving to work.

The department that was most effected by telecommuting was finance as they had 4 full time employees telecommuting in April and May. As of June 1^{st,} most of the staff returned to work at City Hall full time, to gear up for the coming phase (3) when City Hall will be open to the Public (hopefully sometime this summer). As of June 5^{th,} there are still 3 finance staff employees telecommuting full or part time. When the Pandemic is over, telecommuting will still be a valuable option



for those employees that cannot work at City Hall due health or childcare challenges.

May 2020: Snapshot

Our dedicated staff have been very busy continuing to serve both our youth and seniors. We are a designated site to provide breakfast and lunch from the Auburn School District. On Friday's we are able to send kids home with meals for the weekend, thanks to your generous donations. We recently started a Family Grab and Go for families to pick up weekend meals on Fridays, again generous community donations make this happen. We look forward to the day we see everyone enjoying our other programs.



PACIFIC COURT

Since City hall closed on March 16, 2020, we have scanned 203 collection files. We are working with IT to set up remote hearings starting June 3 via Zoom with livestreaming to YouTube. People can appear via video or telephone. From March 16 to May 29, we have rescheduled 12 court day calendars and mailed out 675 notices for hearings to be rescheduled. We still have 2 more court day calendars to reschedule.

Court is preparing to open for in-person hearings when King County enters Phase 3 by following CDC guidelines

Social distancing -

We are changing the calendar structure by setting a few cases every 30 minutes, adding Plexiglas in the courtroom around participants, changing entry procedures by limiting the number of people inside the building at any given time and limiting access to certain public areas.

Extra cleaning -

Public tables used in the courtroom will be wiped between each case, microphone covers will be changed between each case, pens will be one time use and put in a box for sanitizing at least once a day, we will be limiting the numbers of forms where a signature is required.

We are very conscious of the protection and personal health and security of all attendees – we will require masks, gloves, etc; and entry procedures will include 'health check' questions and temperature screenings.

Hello everyone. I hope you are all well and staying healthy during this very different spring. Here is an update about how COVID-19 has impacted your police department.

We are fully staffed and officers are out handling calls for service and doing proactive work.

Staff will try to maintain social distancing guidelines when we can and may try to handle some calls over the phone or outside.

We still face restrictions in booking suspects for many non-violent crimes at jails. The lobby will be closed until King County enters phase 3 of the state's recovery plan.

We are planning to renew limited fingerprinting for new CPL applications using an appointment system.

Over the last month, Staff at the Police Department helped Pacific Partnerships and the Community Services Department to collect and distribute food to residents at Rainier Vista Apartments.

Status of key Public Works services during Covid-19

The Covid-19 virus requires us to rethink how we do some of our public works activities. At the same time many of the things we do stay the same. The Public Works Crew continue to make sure the City has a clean source of water so citizens can clean their hands, clothes, and selves. We continue to tend to utility concerns. However, we have to do these things being mindful of physical distancing.

During the months of April and May, the City elected to divide the crew in to two teams to reduce the risk to staff health and provide some assurance we would have staff available for public works emergencies, if someone should contract the virus. All staff have remained healthy. The City Public Works department is back



up to full force. Now comes the challenge of catching up on some neglected maintenance, especially in the parks.

Most of the work the crew performs requires minimal direct interaction with citizens. If you see crew members and need to contact or converse with them about a concern, please maintain a distance of at least six feet and wear a mask. We need to keep our crew healthy to continue to serve you.

Public Works management and the City Engineer have continued to work at City Hall or remotely: reviewing public and private development project plans; coordinating design and construction projects; inspecting construction activities; etc. We have pursued a grant for construction funds for West Valley Highway between the northerly City limits and the County line. Staff have continued to work on our storm drainage permit activities.

Soon City Hall will be reopening. You will notice some differences. We have constructed shields at the service counters to protect our staff. There are dispensers of sanitizer at each door and counter. Facilities maintenance staff will be cleaning surfaces more often. We are taking numerous precautions to protect the health of staff and public, we request you do the same. Below are some things to do for the health of all:

If you are sick (fever, coughing, sneezing, etc.), don't come to City facilities, please stay home and take care of yourself.

Wash your hands regularly with soap and water, or use sanitizer.

Wear a mask and maintain a distance of at least six (6) feet from others.

Explore options that don't require a trip to the City facilities:

*Pay your bills on line *Pay your bills at the drop box *Apply for permits via email Call ahead for City business and arrange an option that may reduce time for in person activities.

COMMUNITY DEVELOPMENT DEPT. - COVID-19 AND DEVELOPMENT REVIEW

Required paper copies of all applications may be submitted only by appointment only. Applicants are required to use face masks at the time of submittal of paper copies. Applicants will only be able to access City Hall at the Milwaukee Blvd. entrance to City Hall.

Payments of fees shall be only be personal check or cashier's checks.

Governor Inslee has partially opened parks and recreation spaces, so we have followed with our local parks to match. The playgrounds and courts remained closed for use, and you still must follow social distancing, but the open space is available for walks and picnics with your household.



A BIG BANG COSTS BIG BUCKS! REMEMBER:

Aerial fireworks and explosives are prohibited within the city limits. Violation is punishable by a fine up to \$1,000 or jail time up to 90 days.





To accommodate the governor's stay home directive in response to the COVID-19 pandemic the city of Pacific needed to modify work that is traditionally performed at City Hall such as office processes and meetings to operate remotely.

First, IT activated systems that allowed personnel to securely connect to the City's computer network and perform their regular work duties as if they were in the office.

Council meetings were moved to Zoom video conferencing allowing all council members and the public to attend the meetings from their homes. Zoom has been an inexpensive and very solid platform for these proceedings. It allows participants to connect using their computers, tablets, smart phones, or even a traditional phone number providing options for everyone to attend and even contribute.

We have also utilized the same conferencing technology to implement remote court sessions. The proceedings are performed in a Zoom conference session which is then broadcast live through YouTube steaming. The live broadcast permits in order to abide by the right of the public to observe the administration of civil and criminal justice in Washington state.
